

## POWERLEAGUE WORLD CUP COMPANY 5s

### Terms & Conditions

**Eligibility:** This competition is open to residents of the UK only who are **18 years of age or older** at the time of entry. Employees of Powerleague are not eligible to enter. A minimum of 2 players must work for the company entered.

**To Enter:** To enter this competition, team captains should complete an entry form for their team and return it to Powerleague Fives Ltd. A £50.00 payment can be made by cheque made payable to "Powerleague Fives Ltd", entries can also be taken on the credit card hotline number 0141-847-5583 or online at [www.powerleague.co.uk](http://www.powerleague.co.uk) or at any Powerleague centre.

Entry is on a first come first served basis. Each participating team will then receive an info pack from Powerleague about the tournament. Teams must consist of 5 to 7 players of amateur status. Team captains must obtain permission from each team member to enter their name on the entry form. Only one entry per person is allowed. Closing date for entries is **1 day prior to listed centre Heat dates – See your local centre for further information.** \* Entry constitutes full and unconditional acceptance of these Terms and Conditions.

### The Tournament:

The Tournament will be run by Powerleague and shall be subject to Powerleague's rules and regulations that will be provided in the information packs. Team members may only play for one team throughout the Tournament. The Heats will be played at all of the 44 national Powerleague Centres between the 18<sup>th</sup> June 2010 and 4<sup>th</sup> July 2010. Details of the centre locations can be found on [www.powerleague.co.uk](http://www.powerleague.co.uk) and if your chosen venue is over subscribed you will be contacted with an alternative.

If this is unacceptable your entry fee will be refunded. No refunds will be given under any other circumstances. The top 2 teams from each Heat will qualify to take part in the National Finals. The National Finals will be played at the Trafford Soccerdome on Sunday the 18<sup>th</sup> July.

The Heats and National Finals will be conducted in a World Cup Group stages format followed by a semi final and final. Details of how the Heats and National Final will be organised will be contained in the information packs and online at [www.powerleague.co.uk](http://www.powerleague.co.uk). Kick off time for the Heats varies from centre to centre, teams will be notified via information packs. Teams will be expected to pay for travel costs and other related costs for the Heats and the National Final.

### Winners:

The official referees will determine the winners of the Heats and the National Final. The referees' decision shall be final. Winners of the National Final may be required to take part in further publicity or advertising. Details of the winning team at the National Final (including surnames of team members) will be available for a period of 2 weeks up to the 2<sup>nd</sup> August 2010 by sending an SAE to Powerleague HQ, Anchor Grounds, Blackhall St, PA 1 1TD. Winners consent to their surnames being made available.

**Prizes:** The winning team of each Heat will receive a mini replica World Cup trophy presented in person at the end of the event.

The winning team at the National Final will win **£1,000** and a full size World Cup replica trophy.

All teams that participate in the National Final will be entered into a prize draw to win a 5 night trip to the country that wins the World Cup. The draw will be made at the conclusion of the tournament and will be for a squad of up to 7 players. If England win the World Cup the prize will be a 5 night trip to New England in the USA.

Prizes are not assignable or transferable. No cash or other alternatives available. POWERLEAGUE reserves the right to substitute prizes of equal or greater value. Prizes may be subject to tax and winners will be responsible for accounting for any tax liability arising.
